Coming Up: Week of March 20, 2023

Hearings this week will address:

- Improvements to dual credit and community college funding
- Book banning and enforcement of classroom censorship concepts through stateapproved instructional materials
- Private school voucher programs, e.g., education savings accounts
- Support for students' mental health and against hairstyle discrimination

Take Action Against Vouchers

Five private school voucher proposals will be considered on Wednesday by the Senate Education committee. **Call your Senator** and let them know that Texans should stay in

Take Action to Stop HB 655

The House Youth Health & Safety Committee will have a public hearing on House Bill 655 that would harm students by removing them from the classroom and forcing them into virtual learning – indefinitely. IDRA joins Texas Appleseed in encouraging all Texans concerned and directly impacted by school discipline to testify and/or contact committee members to oppose this harmful bill.
