Action Alert: Help Preserve High-Quality College Opportunities for Texans

On Monday, the <u>House Higher Education Committee</u> will consider two bills that threaten the quality and accessibility of Texas higher education. <u>Senate Bill 17</u> bans diversity, equity, and inclusion initiatives in colleges and universities. And <u>SB 18</u> bans faculty tenure at public higher education institutions in Texas.

These bills attempt to compromise students' academic and social experiences on college campuses and make college faculty less diverse and inclusive of different backgrounds and ideas. DEI efforts ensure that students are supported in every aspect of their lives and college careers – from access and affordability to successful graduation. Banning tenure is an assault on academic freedom and would compromise how Texas universities attract top researchers and educators.

Highlights from Last Week

Priority Bills Target LGBTQ+ Youth

Advocates for diversity, equity and inclusion and trans rights gathered at the Capitol for several events last week to oppose several censorship, anti-DEI, and anti-LGBTQ+ bills. The House Speaker cleared the House gallery in response to advocates protesting these harmful bills, and Capitol police arrested two peaceful protesters. Many advocates, including organizations collaborating through the <u>Teach the Truth Coalition</u>, are still fighting back against these harmful proposals, which include SB 8, which creates sweeping bans on discussing gender and sexuality throughout all pre-K through 12th grades and a private school voucher program; SB 13, which creates library book censorship council in school districts; and HB 900, which restricts the content of school library books and materials.


